




GOVERNING BODY MEETING No-05 dt-04.05.2017

4. Manoj Kumar Patel, GB Member, PET was authorised to make the Land demarkcation by the proper authority.



5. It was decided that the Hostel committee with the advice of Principal will appoint the Hostel superintendent and other required staff time to time in rotation basis for smooth running of the hostel.

6. The Principal-cum-Secretary and staff representatives informed the GB today that Sanyasi Patel S/o - Ex-Secretary late Porsanna Kumar Patel had asked for many documents related to college through RTI and all the documents had already been given to him. He came to the college on dt 12/03/2017 to discuss this matter where he demanded Rs 15 lakhs.

GB felt that he is blackmailing the college by the name of his father. It was decided that the college will not pay any money to him.

7. The Principal-cum-Secretary informed the GB that a so-called vigilance officer came to the college on dt 17/04/2017. He told the Principal that he had received complaints regarding fees collection. He asked for some receipts & vouchers which were given to him. After this, he has been threatening from the mobile No- 9556945984 and demanding Rs 7.5 Lakhs.

It was decided today that no money will be paid to that person. The Principal-cum-Secretary was advised

to proceed to the Police Station if any threatening comes from that person.

8. Accounts committee with the Principal informed the G.B today that the accounts report of the previous two session i.e. 2014-15 & 2015-16 was not possible to produce before G.B as asked in the previous meeting because of the non-cooperation of Manarajan Patel, Junior clerk. He denied to receive the notice by the Principal-cum-Secretary.

After discussing the matter the Principal-cum-Secretary was advised to hold the salary of Manarajan Patel, clerk till the next order of the G.B. Further it was decided that an enquiry committee may be formed very soon to examine and enquire into the suspicious role of Manarajan Patel, clerk regarding accounts, admission, examination and other related matters to himself and college affairs.

9. The accounts committee informed the G.B that a sum of Rs 98,891.00 Rupees Ninety Eight thousand Eight hundred Ninety one only has not been deposited in the college account by Ashok Kumar Bhainsa, clerk in the session 2016-17.

Though it is an act of violation, it was decided that the amount should be recovered within one month and



completed with the principal and accounts committee accordingly.

10. The Principal-cum-Secretary informed the G.B that the ministerial staff of the college for not performing their duties properly, even some staff are not able to read and write.

It was decided to examine this matter by a committee.
